Update to Students who completed First Aid Training after 1 November 2020

This update is relevant to students who have completed a First Aid course with St John Ambulance Qld since 1 November 2020.

The Australian Skills Quality Authority (ASQA) has conducted a routine audit of St John's First Aid training program and has identified some areas for improvement in our assessment processes. They have not raised any concerns with the training – only with the assessment. As the updated national Units of Competency are implemented from 1 February 2021, these assessment issues will no longer exist.

We want to assure you that the First Aid training you have received is of the highest standard, and your St John First Aid certificate continues to be valid.

St John is working with ASQA to ensure the areas for improvement are addressed, and we will be in touch with any potentially affected students if there is anything they need to do.

What's happened?	The Australian Skills Quality Authority (ASQA) conducted a routine audit of St John's First Aid training program in late 2020 and has identified some areas for improvement in its assessment processes. Note: St John Western Australia operates as a separate Registered Training Organisation and was not included in the ASQA audit.
Who is ASQA?	The Australian Skills Quality Authority (ASQA) is the national regulator for vocational education and training.
Why was St John audited?	All registered training providers are regularly audited by the regulator. This was a routine audit.
What did ASQA find?	ASQA has identified some areas for improvement in St John's assessment processes.
What does St John have to do?	St John is working with ASQA to ensure the areas for improvement are addressed.
	The audit relates to First Aid training assessments completed between November 2020 and January 2021. We are contacting these students and will let them know if there is anything they need to do.
